#### **REGARDING MARKETING PACKAGES**

Marketing Form Requirements: It is the policy of RIAOC to promote professionalism in the marketing of investment real estate; therefore RIAOC provides and encourages the use of its standardized marketing forms. However, in an effort to increase property inventory at RIAOC meetings, any form providing information on an investment property listing will be acceptable for distribution with the inclusion of the following information: (1) Property address (except Bus Ops), (2) Price and terms, (3) Type of listing, (4) Commission, (5) Contact information for listing agent.

Those Who May Distribute Fliers at RIAOC: Effective March 8, 2010, Non-RIAOC members may distribute fliers promoting information on an investment property listing or a transactional-related affiliate service for a \$10 "table fee" per meeting.
