To be considered for a scholarship, you must meet all of the eligibility requirements and <u>complete the scholarship application form below as well as mail in the required materials by Wednesday, April 1, 2020.</u>

## **Eligibility Requirements**

This scholarship program is for students enrolled at a California College or University pursuing a degree for professions which are centered on, or support a career in real estate transactional activity such as Real Estate Brokerage, Real Estate Finance, Real Estate Management, Real Estate Development, Real Estate Appraisal, Real Estate Planning, Real Estate Law, Commercial Real Estate, and Other fields of study the Trustees believe worthy of consideration.

In addition, the other minimum requirements are as follows:

- Serious commitment to a real estate career
- Currently enrolled in a two or four year college in California
- Enrolled at the time of application in a minimum of six units, including one real estate or real estate-related course
- Completed a minimum of twelve college level course units within the last four years.
- Completed at least two Real Estate or Real Estate related courses
- Maintained a cumulative grade point average of 3.0 or higher from all college/universities attended

#### **About the Foundation**

The California Association of REALTORS® Scholarship Foundation was established in 1948. The foundation, which was originally called the Glenn D. Willaman Real Estate Foundation, was suggested and started at the Silver Anniversary Testimonial Banquet for Glenn D. Willaman, the Association's first Executive Officer, at the 42nd Convention of the California Real Estate Association (as C.A.R. was previously known) in 1946. The Association wished to honor Willaman for his twenty-five years of service to it and started the Foundation with \$1,874.38 in cash, a \$1,000 bond and some donation pledges.

The purpose of the Foundation is to provide scholarships to help students whose intelligence, qualities of leadership and health make them assets worth developing for the future good of the state and encourage

people going into the real estate business to obtain a quality real estate education. The C.A.R. Scholarship Foundation is a 501 (c)(3) public charity.

## **Document Upload Checklist**

Throughout the application, you will be asked to upload various documents. Please have the documents and/or pictures of the items below ready to upload onto this form. If you are unable to upload these materials, you may also email them to scholarship@car.org.

- California Driver's License or Other State Idenitification card. Students must be a legal resident of California for at least one year prior to the date of application.
- 300 word typed essay explaining your career objectives.
- (Optional) Proof of Enrollment in University showing Current Classwork. Please note: You will need to mail in a hard copy of your Official Transcript(s) for your application to be considered complete. Your Official Transcript will likely include courses you are currently enrolled in, although some Universities and Colleges do not do this. Please check with your school to see if current courses display on your transcript. If they do not, you should upload another document that shows your current coursework.
- (Optional) Unofficial Transcripts from Universities/Colleges Attended Over 4 Years Ago. If you attended college/university over 4 years ago, you may upload unofficial transcripts from those schools as supplemental materials for the Trustees to review.

### Required Materials to Mail In

The original materials listed below <u>must be mailed in and postmarked by Wednesday, April 1,</u> **2020** for your application to be considered complete.

- All Official Transcripts from Colleges/Universities attended within the last 4 Years. Only official, sealed transcripts will be accepted. If your school offers Official E-transcripts, please have your school email it to <a href="mailto:scholarship@car.org">scholarship@car.org</a>. Official transcripts will be used to verify coursework eligibility requirements including: 1) you have completed at least 12 units and 2 real estate related courses in the past 4 years and 2) maintained a cumulative GPA of 3.0 or higher from all Colleges/Universities attended.
- 2 Sealed Letters of Recommendation with Wet Signatures. 1 letter must be from a faculty member on school letterhead and 1 letter must be from a REALTOR®. Letter(s) from faculty must be on school letterhead and all letters must be sealed and include wet signatures.

## **FAQs**

Interested in applying for a C.A.R. Scholarship, but have a question? Here are a few of the most frequently asked questions.

## Q. How many C.A.R. Scholarships may I win per year and throughout my studies at a California college or university?

A. An Applicant may win up to 1 per calendar year and 2 total in his or her lifetime.

## Q. How often does the Foundation award scholarships?

A. The C.A.R. Scholarship Foundation awards scholarships 1 time a year during the Spring C.A.R. Business Meetings, which take place in Sacramento each year.

### Q: How do I apply for a C.A.R. Scholarship?

A: Our application is posted on our **Scholarship page**. The application includes a checklist of items that need to be submitted in order for your application to be considered complete.

## Q: Is there anything else I need to do in addition to submitting an application?

A: Yes, there will a phone interview. A Scholarship Foundation Trustee will contact you approximately 1-2 weeks after the application deadline

#### Q: When will I find out whether I received a scholarship?

A: Letters are mailed/emailed to all of the applicants approximately 4-5 weeks after the application deadline to inform them whether they received an award or not.

#### Q: Can I sumbit unofficial transcripts?

A: Applicants must submit official transcripts for schools attended in the past 4 years.

#### Q. What is the minimum GPA requirement?

A. Students must have maintained a cumulative grade point average of 3.0 or higher from all colleges/universities attended.

## Q. I am a freshman student at a 2 year college and currently enrolled in one real estate course, does this qualify me for a scholarship?

A. Students must be enrolled at the time of application in a minimum of 6 units. At least 1 course must be Real Estate or Real Estate related. Students must also have completed a minimum of 12 college level course units with the last 4 years. At least 2 courses must have been real estate or real estate related courses.


## Q. If I am a high school student interested in pursuing a career in the real estate field, do I quality for a scholarship?

A. No, an individual must be currently enrolled in a 2 or 4 year college in California and already have completed 12 units.




## Where to Find Weekly Preview/Tour Sheets

The Newport Beach Association of REALTORS® broker preview/tour sheet can be accessed 2 ways.


1. You can go to the Newport Beach Association of REALTORS® website.
