



## **COMMON AUDIT FINDINGS**

- Trust fund shortages on property management and broker escrow audits
  - \$5 million in shortages
  - ✤ 31.1% of audits had shortages
- Lack of broker oversight
- Broker-controlled escrow activities and failure to report to DRE
- Delays in providing records
